**Project brief**

At the request of Simone Jorgensen of MJM Consulting Engineers, soil sampling, analysis and reporting was carried out to assess the site for a proposed residential development on 5 May 2020. The document provides information about the site and soil conditions from field observations and laboratory analysis.

### **Physical characteristics of the site**

A desktop review and investigation of the topography, hydrology, soil, lithology, geology and hydrogeology of the site has been undertaken and are as follows:

#### **Topography**

The Wagga Wagga 1:25,000 Topographic Map (Sheet 8327-1N) indicates that the site is located at an elevation of approximately 225m AHD. The site landform is classed as a simple slope and the slope class is moderately inclined.

#### **Vegetation**

The site is devoid of vegetation.

#### **Hydrology**

The nearest named waterway is Murrumbidgee River located 2km to the south of the site. Due to the relative incline of the site, rainfall is likely to both run off and infiltrate into the relatively permeable topsoil.

#### **Weather**

The average rainfall for Wagga Wagga is approximately 526.8mm per annum, with the wettest months being October, June and July. Annual mean evaporation for the region is 1715.5mm with mean daily evaporation ranges from 1.2mm in July to 9.2mm in January. Wagga Wagga is characterised by cold wet winters and hot dry summers with mean maximum temperatures ranging from 12.9°C in July to 31.9 °C in January and mean minimum temperatures ranging from 1.3°C in July to 15.9°C in February. Rainfall, temperature and evaporation data from Wagga Wagga Agricultural Institute 73127 ([www.bom.gov.au](http://www.bom.gov.au)).

#### **Soil & Landform**

The site lies within the mapping unit Id from the Soil Landscapes of the Wagga Wagga 1:100 000 Sheet (DLWC, 1997). The map unit Id is described as:

##### ***Id – Lloyd (Erosional Landscapes)***

*Landscape:* rolling low hills of Ordovician metasedimentary rocks. Local relief 30 - 60 m; slope gradients 10 - 20%. Broad crests and ridges, long waning mid to lower slopes, and broad drainage depressions. Extensively to completely cleared mid-high open-forest.

*Soils:* shallow (<50 cm) Paralithic Leptic Rudosols on crest, ridges and upper slopes; moderately deep (50 - 100 cm) Mesotrophic Red Chromosols on mid to lower slopes and moderately deep (80 - 150 cm) Mottled Mesonatric Brown Sodosols in drainage lines.

*Limitations:* high erosion hazard, steep slopes (localised), foundation hazard (localised), mass movement, shallow, stony and strongly acid soil (localised on ridges and upper slopes).

#### **Lithology and Geology**

Undivided Ordovician metasedimentary rocks-thinly interbedded siltstones, shales, and phyllites, with minor schists and minor quartzites. Lithology is highly variable in short distance. Relatively thick 0 - >3 m) colluvial and slope-washed clayey sediments occur on lower slopes and in drainage depressions.

#### **Hydrogeology**

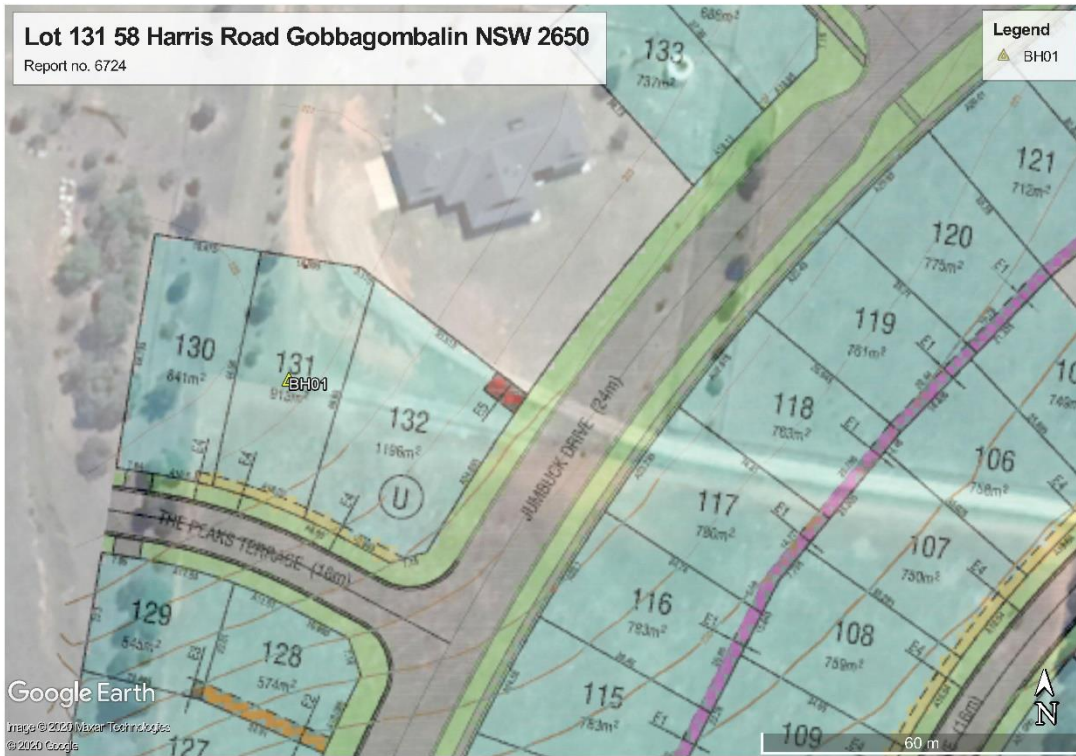
From the Geoscience Australia hydrogeology dataset, the groundwater beneath the site is described as porous, extensive highly productive aquifers

### Site Condition

Through site investigation, field observations, in situ tests and laboratory analysis the following site geotechnical model has been developed. Details of the general conditions encountered with a field description of the soil, engineering properties and the location of the boreholes can be seen as follows, Table 1, Figure 1.

### **Site Classification**

Based on the field assessment and laboratory data and assumptions therein the site is classified as **MD - Moderately Reactive Deep Drying** by reference to AS2870:2011.

### **Assumptions**

Site investigation and classification was carried out by reference to AS2870:2011.

The proposed building is a single storey residential development.

This classification is based on the footings being founded into the underlying CL material. If the footings are not into the specified material the site classification will need to be reassessed.

An allowable bearing pressure of up to 50kPa and 100kPa for raft slab beams and strip footings respectively may be adopted.

If more than 0.4m of uncontrolled fill is present or placed, or if depth of excavation within the building area extends more than 0.5m below the existing surface, the above classification will need to be reassessed.

Any earthworks on site will be carried out by reference to AS3798: 2007.

If any unconsolidated or saturated soils are encountered during excavation, or conditions that are not alike the above description, the site supervisor should be informed, the work stopped and this office be contacted immediately for further evaluation.

Where trees and large shrubs are removed from the site all roots are to be removed and voids replaced with compacted fill by reference to AS3798:2007.

The soils investigated are all natural ground and no free groundwater was encountered at the time of the investigation.

Site drainage and vegetation limitations are adhered to as per the CSIRO Foundation Management and Footing Performance: A Homeowner's guide, BTF-2011
